- 3. I agree to sell only approved products and not to violate any Trademark or copyright restrictions.
- 4. I acknowledge full responsibility for all my activities and actions at the Market and for those employed by, or assisting, me. I agree to defend, hold harmless and indemnify 1st Choice Antiques.com, LLC, Kathryn Jacobson, Ray Bono and Abe Nieto from any liability, cost, damage, or expense, including reasonable attorney's fees, which arise from my participation in the Market or use of the vendor's space. I will always act professionally with everyone at the Market and acknowledge that my participation may be terminated if I don't.
- 5. I accept responsibility for payment of all fees required to participate in the Market. I acknowledge that there will be NO REIMBURSEMENT OR CREDIT for any fees pre-paid if I decide to no longer participate at the Market, if I am banned from the Market OR I CHOOSE TO NOT ATTEND ANY individual WEEKLY MARKET.
- 6 This agreement is a license, and it can be terminated at any time. I have no leasehold, easement or other interest in the space assigned to me at any time and my space can be changed as necessary.

RULES, REGULATIONS, TERMS AND CONDITIONS

IMPORTANT: BY SUBMITTING YOUR APPLICATION, YOU ACKNOWLEDGE YOUR AGREEMENT TO COMPLY. KEEP A COPY FOR YOUR RECORDS.

1. VENDER EQUIPMENT

Vendors must use a 10' X 10' WHITE TENT (NO EXCEPTIONS) and tent weights (mandatory – minimum of four 20 lb. weights), tables, and bring a garbage bag. Appropriate table covers are required. YOU must clean up at the end of the day and remove all garbage, broken items and food.

2. VENDER BOOTH SPACE

Seasonal vendors will be assigned a space. Others may be subject to relocation.

- 3. No sharing of space is permitted. Both Violators will be terminated. Vender's products and set-up must not be placed beyond booth space boundaries. ALL Vendors must be prepared to sell from all 4 sides to accommodate sidewalk buyers.
- 5. Venders must be prompt for set-up and clean-up. THE STREET BARRIERS WILL GO UP AT 8:00 AM AND COME DOWN AFTER 2:00PM. THE MARKET IS NOT RESPONSIBLE FOR ITEMS BROKEN DURING SET UP OR BREAKDOWN. YOU MUST REMOVE THEM.
- 6. PARKING RATES ARE SET BY THE CITY. THE MARKET HAS NOTHING TO DO WITH THEM. PARKING IS AVAILABLE IN ALL GARAGES. THE CITY HALL GARAGE ACCEPTS HIGH PROFILE VEHICLES. THERE IS A <u>PRIVATE PAY SURFACE LOT</u> AT DIXIE AND CLEMATIS. PARKING IS AT YOUR RISK. WE DON'T PAY TICKETS.

7. SET-UP / BREAKDOWN / CLEAN-UP

Set up begins after 5:00am. Every vendor MUST be completely set-up by 8:30 AM. All vehicles MUST BE REMOVED BY 8:00 AM..

BREAKDOWN STARTS at 2:00 PM. STREETS MUST BE CLEAR BY 4PM. Even if a vendor sells out, the vendor must remain in vendor's booth until 2:00 PM. Breakdown before 2:00 PM may result in permanent expulsion from the Market. VENDORS MUST DRIVE IN, UNLOAD AND MOVE YOUR VEHICLE BEFORE SET UP. AT CLOSING, YOU MUST PACK UP AND BE READY TO LOAD BEFORE GETTING YOUR VEHICLE. NO EXCEPTIONS.

8. CLEAN-UP – Every item you bring or use must be removed by you, even broken and discarded items. Remove your Garbage bags. DO NOT USE THE GARBAGE CANS ON CLEMATIS STREET FOR YOUR ITEMS UNDER ANY CIRCUMSTANCES. Failure to comply with these rules will result in a \$100.00 fine per instance in addition to any cleaning fees paid to the Porters which must be paid before the next Market. Multiple fines will result in expulsion. THE \$100.00 FINE IS THE FEE CHARGED BY THE CITY TO US PER VIOLATION.

THE MERCHANTS ON CLEMATIS AGREED TO ALLOW THE MARKET TO OCCUR. IF THEY COMPLAIN, WE WILL BE CLOSED DOWN. BE MINDFUL. IF YOU ARE HUNGRY OR THIRSTY, USE THE RESTAURANTS. THEY WILL APPRECIATE IT. THEIR RESTROOMS ARE FOR THEIR PATRONS. THE CITY HALL LIBRARY IS OPEN AND HAS RESTROOMS.

VEHICLE REGULATIONS

In the event of rain after the market has opened, the Manager will make the determination when vehicles will be allowed on site. Street barriers must never be moved after the beginning of any Market or before the end of the Market. Danger to patrons and vendors will prohibit future participation.

THE 300 BLOCK ENTERS AND DEPARTS AT OLIVE AND CLEMATIS. DO NOT SPEED.

THE 400 BLOCK ENTERS AT DIXIE AND CLEMATIS AND DEPARTS AT CLEMATIS AND QUADRILLE. DO NOT SPEED.

Unexcused absence for 2 CONSECUTIVE Saturdays will result in loss of a permanent spot.

- MISCELLANEOUS RULES
- No sales, use or possession of alcoholic beverages, food for sale or firearms is permitted.
- Vendors are responsible for collecting and remitting their own sales tax.
- No vendor business flyers/promotional materials except business cards.
- Vendors are responsible for damages to any person or business location caused by the vendor's negligence, including flying tents. Securing individual Insurance is advised.

ENFORCEMENT OF RULES

- 1. Management is responsible for enforcing the rules. Continued violation will result in expulsion from the Market with no reimbursement of fees paid and no future participation.
- 2. Complaints regarding product legitimacy, operational detail or conduct of another vendor must be submitted in writing to the Market management for resolution.
